New Business

Sweat Equity Bins - Kris provided an overview of an application she submitted to
Deschutes County for consideration of sweat equity bins. If approved, these 30 cu yard
bins will be strategically placed around the neighborhood for property owners to easily
dispose of their yard debris (tree limbs, pine needles, grasses, etc). This is free of
charge. She has requested 4 or 5 bins for DRRH6 use and if approved, details will be
forthcoming.

Open Discussion

 Property asked about consideration of a project for improvement at the boat launch at the community area. Former POA member shared that over the years, this has been a request; however, it creates a liability to the POA as an "attractive nuisance".

Jen shared that this project has been mentioned numerous times by different homeowners and that following the survey to the association, that all projects suggested will be explored and researched to determine cost and feasibility to POA as a community
